5 Year Guarantee

Our guarantee includes the following –

This runs from the date of delivery or installation and that what is agreed between Signs Now UK and the customer. Depending on the product or sign each material has a different life expectancy.

However, if not stated the standard guarantee given is 5 years on PERMANENT SIGNS.

Temporary signs such as banners, exhibition signs and short-term life expected signage will have no warranty.

High standards of workmanship shall be used from fabrication to installation.

Guarantee does not cover any failure attributed by malicious damage, vandalism or force majeure.

Colourfastness during the guarantee period on outdoor exposed surfaces can be expected to exhibit at least some degree of change.





Environment – Waste Carriage Licence



Where possible, materials used in the manufacture and installation of signage will be environmentally friendly both in manufacture and disposal.

Signs Now is committed to leading the industry in minimising the impact of its activities on the environment.

Signs Now are registered as Licensed Waste Carriers with the Environment Agency.

What it means

The duty of care is a law which says that we take all reasonable steps to keep waste safe. All waste is transported and recycled or disposed safely.

We take all reasonable steps to fulfil the duty and complete a Duty of Care: Transfer Note.

Steps we take:

We store it safely and securely and prevent it causing pollution or harming anyone.

1. Remove existing old signs from site
2. Make it secure. Keep it in a suitable container. Any loose waste is put into a skip or on a lorry and covered.
3. Waste is transported to a controlled registered authorised waste recycle or disposal centre.
4. All waste is described and noted in writing on an official transfer note and kept for reference.

National & European Standards



Signs Now UK abide by the National & European Standards set out below -

BS 559:2009 Specification for the design and construction of signs for publicity, decorative and general purposes

BS 559 specifies requirements for the design and construction of signs for publicity, decorative or general purposes, at internal or external locations.

It is applicable to both illuminated and non-illuminated signs, whether fixed or portable.

BS 559 provides guidance on:

- Service life
- Sign materials
- Sign design and construction
- Illuminated signs
- Marking and literature.

The 2009 latest edition is a full revision of the standard, and introduces changes to:

- Requirements for the calculation of resistance to wind pressures
- Requirements for foundations for fixed free-standing signs
- Protection against corrosion and protection from damage by birds and rodents
- Requirements for LEDs
- Guidance on working with vinyl films.

Descriptors

Signs, Sign lighting (buildings), Fixed, Portable, Advertising signs, Decorative lighting, Design, Installation, Life (durability), Metals, Wood, Plastics, Surface spread of flame, Wind loading, Foundations, Corrosion protection, Thermal expansion, Joints, Mechanical properties of materials, Adhesives, Panels, Waterproof materials, Temperature-rise limit, Letters (symbols), Dimensions, Fixing, Light-emitting diodes, Electrical safety, Marking

PASMA (prefabricated Aluminium Suppliers & Manufacturers Association) provide a recognised standard for safe use of Aluminium Towers.

Our people have the knowledge to work safely in the use of this work equipment. They are accredited members of PASMA, practical on the safe erection, dismantling and use of mobile alloy and fibreglass access towers, which are approved to BS EN 1004 : 2004 and which carry a current British Standard or other equivalent mark of approval.

 - Complete an NVQ level 2 in Signs Making
- Or
- Complete an NVQ level 3 in Sign Making
